Our website privacy policy is designed to describe our use of any and all information and data that you may share with us or that we collect from you [on this website](#). This document is a policy that forms an agreement between us, Construction Youth Trust, the owner of this website, and you the user of this website www.constructionyouth.org.uk

Please take the time to read this privacy policy as it defines the terms of use of the website by you, the user.

Relevant definitions

Construction Youth Trust, or Construction Industry Trust for Youth, we or us Construction Industry Trust for Youth, a limited company incorporated in England and Wales, registration number 04461612 and registered charity, number 1094323.

Our registered offices are at London Scottish House, London, SW1P 2DX.

User or you

Any third party what may access the website who is not an employee or contractors of Construction Youth Trust.

Website

Refers to the website that you are currently accessing on the domain www.constructionyouth.org.uk or any sub domain of this domain, unless we tell you otherwise in that website's terms and conditions or privacy policy.

Data

All the information provided by you via website contact forms, email submissions, comments on blogs and news and via any other method available on our website.

Cookies

A cookie is a text file that we might place on your computer when you use this website. The website will then use this file to store information in order to improve user experience, track information about your visit or for functional purposes. More information about the types of cookies used on this website is in the Cookies clause below.

Data Protection Laws

Any laws that applies to the protection of your personal data including the Data Protection act (2018) and the UK GDPR.

GDPR

The UK General Data Protection Regulation.

Cookie Law

Refers to the Privacy and Electronic Communication (EC Directive) Regulations 2003 and as amended by the Privacy and Electronic Communication Regulations 2011.

Persons

Includes companies, agencies, firms, individuals, government entities, trusts, charities, partnerships and any other organisation.

1. What is covered by this privacy policy?

The privacy policy applies to the actions of users of this website and this website alone, not any websites, social media platforms or any other location linked to or referred to on this website.

Construction Industry Trust for Youth are the data controllers and we will define how your data is used and will endeavour to update this document to ensure it is accurate.

2. What data do we collect on this website?

We may collect the following information from you on this website:

Contact information such as email addresses, telephone numbers, names and any other contact details. We collect this information in accordance with this privacy policy

3. How do we collect this information?

We will collect your data in a number of ways:

- Data you may give to us via web forms that you complete
- Data that you may send to use via email to addresses listed on our website
- Data that we collect automatically

4. What data is collected automatically?

When you use this website, we may do the following:

- Automatically collect information about how you use the website. We use this information to help us to improve the website and we may collect your IP address, the date and time of each visit, pages visited and how you interact with the website's content
- Automatically collect information using cookies. We will do this in line with the settings you've applied for cookie usage in your web browser. We detail the cookies we use on this website in the section below entitled 'cookies'

5. How will we use your data?

We may use the information that you provide us to from time to time to improve our services and website user experience. We may also use it for:

- Internal record keeping
- To send you email marketing, should you have opted-in to this
- To contact you, if you requested that we should do so

We may retain your data if we deem it necessary for legitimate interests. You are entitled to object to this, if you do, please contact the data processor (detailed below) and we will update or delete your records.

6. What about data breaches?

7. How long will you keep my data?

We will only keep your data for as long as is deemed necessary to fulfil the purposes outlined in this privacy policy, or until the time that you request it is deleted.

Please note that even if we delete your data, we may be required to keep it in an archive for legal, tax or regulatory purposes as governed by UK law.

8. What are my rights?

According to UK law, you have the following rights relating to your data:

Right to access You have the right to request copies of the data we hold about you at any time, or to request that we modify or delete this data and where reasonably possible we will fulfil requests. We will not charge you to provide you with the information we hold about you, unless your request is “manifestly unfounded or excessive”. Where legal, we may refuse your request, but we will tell you the reasons for the refusal.

- **Right to correct** You have the right to request that your data is rectified if it is inaccurate or incomplete.
- **Right to erase** You have the right to request that your data is deleted and removed from our system.
- **Right to restrict** our use of your data You have the right to block us from using your data or restrict the way we use it.
- **Right to data portability** You have the right to request that we move, copy or transfer your data.
- **Right to object** You have the right to object to our use of your data including use for legitimate interest.

9. How can I exercise these rights?

10. Cookies

Our website may place cookies on your computer to help us to improve the experience of using the website. We have carefully selected only the essential cookies and have taken all the necessary steps to ensure that your privacy is protected and respected.

All cookies use on this website are governed by the current UK cookie laws. You will be notified of our use of cookies when you first access the website. This message will be displayed on a horizontal bar and you will be required to consent to the cookies in order to dismiss this notice. If you decide not to dismiss this notice, it will be deemed that you have accepted the use of cookies by the continued use of the website.

We may use the following cookies:

- **Necessary cookies** We use some cookies to ensure that our website operates as we intend it to. These include, for example, any cookies that enable you to log into secure areas, use shopping carts etc.
- **Analytical cookies** We use cookies to monitor the number of visitors on our website and track how they move around the site and engage with its content. We will use this information to improve how our website performs and make changes to its structure and content.
- **Functionality cookies** We use these cookies to recognise you on return visits to our website. We might use it to remember that you agree to the use of cookies, for example, so the notice will not display. We might also use it to avoid displaying repeat pop-ups (if used) or perhaps to remember your region for choice of language or your selection of accessibility features.
